

## **Competition Rules**

5. The winner will be randomly chosen via a certified and computerized method of selection
6. No responsibilities will be accepted for entries lost, delayed or damaged in transmission
7. Entries reflected on records will be treated as the only validation source and will be the only evidence of successful entries

**Closing Dates:**

Entries will close at 17:00 of the 23 December 2020, an hour prior the draw, during the competition

**Prize:**

1. Prize will be a car to the value of up to R1 000 000.00
2. The winner will arrange to collect the prize at Harmony Empire Group offices
3. The prize is not transferrable and cannot be exchanged for cash
